Sir/Madam,

This is with reference to your online application executed on 13.02.2012, on the above subject. In this connection, I am directed to convey the sanction for extension of provisional affiliation of the school with the Board for its Secondary School Examination for a further period of five year(s) w.e.f. 01.04.2012 to 31.03.2017 subject to the fulfilment of the following conditions:

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
3. The School is required to apply online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000 per month. (Amended Rule 15.11)
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board. (Amended Rule 15.11)
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation-Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class X:-

6. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
 7. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.
 8. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE Schools.
 9. Other conditions are enclosed as per Annexure 'A'.
 10. Special conditions to be complied within three months:

- The school is required to submit the result of the Board Examination for the classes X & XII for the last 3 years.
- School is required to pay salary and other allowances- at par with State Govt. employees/Vith pay commission as per recommendation of District Magistrate, Jhansi and clerical staff should also be appointed for proper functioning of office work.
- The school is required to submit a copy of the EPF Code No. allotted by the concerned department along with a copy of the chalan
- Balance fee of Rs. 15,000/- is required to be remitted immediately.
- The school is required to maintain the Section Teacher ratio of 1:1.5 at each level as per Affiliation Bye-Laws of the Board.
- The school is required to submit a latest copy of Certificates regarding availability of Fire, Sanitary and drinking water Safety.
- School Managing Committee is required to be reconstituted as per norms prescribed by the Board in this regard. Also 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that approved by the Board as its nominee in the School Managing Committee.
- The school is required to improve its financial condition.
